1. **Priority research area: Young men** 2nd ice-breaker meeting held 26th November with Afghani young men in Salford was discussed. Agreed harassment and assault described at this event was tip of iceberg.

Action: Cath to organise translation of the notes from this meeting for those who had attended for circulation via Rhetta.

2. New post to be funded by Salford Council for minority ethnic communities, including refugees and asylum seekers and an advocacy project were discussed.

Action: Nilofar leading on progression of this

3. Next event with Afghani young men living in Salford set for 12th December and it was agreed that it should be used as a way of documenting incidents and discussing possibility of linking with schools to reach children and parents.

Action: Rhetta to send out letters to confidential list of community members and discuss meeting point via Abdullah. Cath said she could take 4 people from Broughton area if they met outside St. James School by 9.30am.

4. The Community Empowerment Fund of £6,000 was discussed.

Action: It was agreed to have a dialogue with CVS.

- 5. The sustainability of RAPAR was discussed as it was currently depending on unfunded time of certain people. Issue not resolved but possibility of building in time costs to future bids discussed.
- 6. The new Crime and Disorder Strategy was discussed and the need to know how to influence this was pointed out. The urgency of the situation was stressed.

Geoff Kirkham felt that GMP could not do anything with senior police for 12th December. Geoff would look into possible funding for a January event.

Action: Krisha Kaur to talk to sector sergeant. A meeting with police to be arranged as soon as possible.

- 7. The need to talk to headteachers about working with children and parents was supported.
- 8. The need to target politicians was discussed.

Action: Linda Corfield to lead on talking to counsellors to decide whom to include.

- 9. The Geographical Information System was discussed and the need for someone to open up a dialogue. The CVS was already linked into CHIPS. No decision taken.
- 10. A mental health conference in London was discussed and Hermione Lovel expressed interest in attending.
